Dear Comrades,

SUB: Renewal of IBA Medical Insurance Scheme for Retired Employees for the period from 01.11.2024 to 31.10.2025.

Head Office vide their circular no. CHO/PMG/2024 - 25/35 dated.04.10.2024 has issued the necessary guidelines for renewal of the said policy. The following are the important points to be noted in this regard.

1. A fresh option is to be submitted online by the retiree / spouse of the deceased employee /retiree who want to renew their IBA Group Mediclaim Insurance policy for 2024 - 25.
2. Those retirees / spouse who had not subscribed to the current insurance policy will also have the option to join **as a one time measure.**
3. **Once the retiree opts out of the policy, he/she will not be allowed to re - enter in the policy.**
4. The available sum insured of base policy for award staff and officers are Rs.3.00 lacs and Rs.4.00 lacs respectively.
5. Top-Up cover for award staff and officers are Rs.4.00 lacs and Rs.5.00 lacs respectively.
6. The premium for the insurance cover is given in the attached HO circular.
7. The last date for submission of online application is 24th October 2024.
8. Head Office will be debiting the premium from 25.10.2024 to 28.10.2024 in batches.
9. It will be responsibility of the retiree / spouse to maintain the necessary balance in their respective account from 24th to 28th October 2024.
10. Our Association is setting up a Help Desk in the "UCO BANK Officers Association Office", 3rd Floor, UCO Bank Building, K.G. Road, Bangalore - 560009 on 14th , 15th and 16th October 2024 between 11 AM and 3 PM. Members are requested to make use of the facility for renewal of the policy.


