SUB: Linking of PAN & Aadhar.

Dear Members,

It has come to our notice that some of our members have not received full pension for the month of February 2025. The main reason for this is non linking of PAN & Aadhar.

As per the following sections of IT Act, linking of PAN with Aadhar is compulsory. The following information is relevant to note:

“Sec 139a read with Sec 139aa of Income Tax Act.1961 as per which last date for linking PAN with Aadhar was 31/03/2021 which was later extended up to 31/03/2024 from time to time.”

Our Head Office had issued instructions to link PAN & Aadhar in 2024 itself. It appears that many of our members have not taken note of these instructions.

Non linking of PAN with Aadhar results in deduction of TDS @ 20% on the annual income, whether the person's income is liable for deduction TDS or not.

In the case of members where almost the entire pension has been deducted as TDS and remitted to the Income Tax Department, the only option left is to file their IT returns and claim the refund of deduction of TDS.

Further some of our retirees may not have applied and received the PAN Card. Such members are requested to apply and get their PAN Card.

Please ensure that the name and date of birth are the same in PAN & Aadhar. There should not be any discrepancy in this regard.

Procedure for Linking PAN with Aadhar:

I. Option 1:

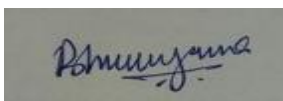
1. Go to the Income tax website.
2. On the left hand side of the portal, under Quick links, select Link Aadhar status, & view the status.
3. If status is 'No',

go to any Aadhar correction centre, & request for necessary corrections as per PAN.
4. Once corrections are updated in the Aadhar main portal, visit 'Link Aadhar' in IT portal & view the fee payment details.
5. Go to e pay tax link & make payment of Rs 1000/-. & Obtain challan.
6. Go to 'Link Aadhar' ' & enter the details. Wait for another 7 days to get confirmation of the status.

II. Option 2:

Contact a Tax Consultant and take his help to link your PAN & Aadhar.

Please complete the above procedure to ensure that your future monthly pension is credited without any difficulty.
