SUB: AIUCBOF Welfare and Benevolent Trust – New membership.

Many of our members are enquiring about joining the medical insurance scheme of the above Trust. The Trust had opened the membership during 2024 -25. There was no communication of new membership during 2025 – 26.

The matter was referred to the Trust and they have given the following clarification:

- 1.Only officers and supervisory staff retired after 01.04.2017 may be allowed to enroll as Members of the Trust after payment of Rs.10,010/- to the Trust as onetime non- refundable donation.
- 2.Members, after submitting the application for membership, are also required to pay an annual donation of Rs.3000/- to be eligible for getting the reimbursement of hospitalisation.
3. However for reimbursement there will be three months waiting period. Three months waiting period will be reckoned from the date of application along with the Demand Draft / UCO Bank cheque by the Trust.

Officers and supervisory staff who have retired after 1st April 2017 and who are willing to join the Medical Aid scheme of the Trust can submit their applications. The necessary application forms are attached.
